As Minnesota taxpayers prepare to file their state income tax returns for the 2025 tax year (filing in 2026), the Minnesota Department of Revenue (MN DOR) offers secure online tools to file, pay, and track Minnesota tax obligations. ### Estimated Tax Payments in Minnesota

If you expect to owe tax for the year and you do not have enough tax withheld from wages, you may need to make quarterly estimated tax payments.

#### Filing Requirements & Deadlines

Estimated tax payments are typically due in:

- **April**
- **June**
- **September**
- **January (of the following year)**

You can schedule and make these payments online.

## Track Your Minnesota Tax Refund

After your Minnesota tax return has been processed, you can view the status of your refund through the Minnesota DOR's online services.

## Minnesota E-Services

- **Check notices or correspondence from the DOR**

Before you file your Minnesota return:


- **Verify that your Social Security number and name match your federal return.**
- **Review withholding and income entries for accuracy.**
- **Confirm refund or balance due totals before submitting.**
